Revised timeline for Admission to Four-Year Undergraduate Programs (FYUGP) / Integrated P.G. Programs with multiple-exit options for the Academic Session 2025-2026.

The Department of Higher Education Government of Jammu & Kashmir **vide No: DC-HE/2025/1152 Dated: 15-06-2025** announced the commencement of **admissions** for the Academic Session 2025-26 for various Four Year Undergraduate Programs (FYUGP) / 5-Year Integrated P.G. Programs (IG) with multiple-exit options across all Degree colleges of J&K, for the Academic Session 2025-2026.

The timeline for the various stages of the admission process, which was contingent upon the declaration of the CUET result by the National Testing Agency (NTA), was included in the aforementioned notification. Now that the CUET result has been declared vide NTA's press release dated 4th July 2025, the revised timeline for the admission process is hereby notified as under:
